



CEEQUAL Term Contracts Awards - Feescale

(Prices from 1 November 2011 until further notice) exclusive of VAT at the current rate.

Fees for formally verified CEEQUAL Assessments of Term Contracts – both for maintenance and multiple small works – need to be agreed between the applicant and the CEEQUAL Scheme Management Team. The fees are based on:

- the annual value of all work undertaken under the contract
- assessment periods – the length of the contract or 5 years, whichever is the shorter
- the frequency of verified assessments – the first year and final or fifth year are mandatory, with annual or biennial verified Assessments in between
- the number of individual work types to be assessed.

The table overleaf presents the fees for each year in which verified assessments are required against the annual value of that work and number of work types up to six. For annual values above £100M and/or numbers of work types greater than six, fees need to be discussed and agreed with the CEEQUAL Scheme Management Team.

If prospective applicants have decided their frequency of Verified Assessment (annual or biennial) and the number of work types, they are invited to use the feescale overleaf to work out the fee, and to complete the Term Contracts Application Form accordingly. Guidance on Work Type selection is in the Scoping section of the Introduction to the Assessment Manual for Term Contracts, page 7.

If prospective applicants are dealing with contracts with annual values above £100M and/or numbers of work types greater than 6, or need to discuss the options on frequency of Verified Assessment (annual or biennial) and discuss how to determine the number of work types, they are invited to complete the Registration of Interest Form below and email it to **Roger Venables** (roger.venables@ceequal.com) who will then respond for a discussion and quotation.
