This feescale needs to be read in conjunction with CEEQUAL's Terms and Conditions available separately but the following key points are:

- 1. Travel, hotel & subsidence expenses of the CEEQUAL Verifier are charged at cost in addition to the above fees. If it is cheaper for the project team to arrange such travel for the Verifier directly and pay for it themselves, CEEQUAL is content for such arrangements to be made.
- 2. The fees quoted are based on a Verifier travelling from the UK to the project site or the offices of a project team member for scoping, including initial mentoring of first-time Assessors where appropriate, and for each verification associated with the Award one verification for all except for a Whole Team with Interim Award, and two for a Whole Team with Interim Award.
- 3. If a Verifier is available closer to the project than the UK, then the fees will be adjusted appropriately. As the number of Verifiers working outside the UK increases, CEEQUAL will be able to reduce the quoted fees to allow for the reduced travel times involved.

- 4. The feescale is based on assumptions on the Verifiers' travel time. Should we be requested to verify a project in a particularly remote area, we reserve the right to charge additional fees related to the Verifiers travel time compared to that assumed in these fees.
- 5. For this Zone the Verifier's travel will normally be by Business Class to enable the Verifier to start work soon after arrival without any recovery time, and re-start their other work on return also without any recovery time.
